## **Joseph P. Fallon, Jr., Memorial Award**

### **Proposal Form**

Joseph P. Fallon, Jr., FPSA, lived and practiced law in San Francisco, CA. He joined the Photographic Society of America (PSA) in 1956 and was active in all divisions. He held many offices in the Society, including Chairman of the Stereo Division and General Chairman of the 1973 PSA International Convention in San Francisco, CA. Mr. Fallon was the PSA Pacific Zone Director from 1973, until his passing June 23, 1983. In addition, he was Membership Vice President-elect at the time of his death.

Mr. Fallon was one of the most well-known speakers in the San Francisco Bay area. From the years 1964 to 1973, he presented as many as 17 programs per year, in addition to evaluating exhibits and travelling often to the Far East on business. Because of his extensive speaking and evaluating services, and continued good will efforts to maintain the general welfare of the Society, Mr. Fallon was elected a Fellow in 1972. He also received the Victor H. Scales Memorial Award in 1977.

The Joseph P. Fallon, Jr., Memorial Award is sponsored by the Yerba Buena Chapter of PSA.

The Joseph P. Fallon, Jr., Memorial Award recognizes outstanding service to PSA in the promotion and development of membership for the Photographic Society of America. This award acknowledges a member's devotion to promoting and sustaining membership in the Society through the creation and implementation of innovative membership programs.

#### **Instructions to proposers of the Joseph P. Fallon, Jr., Memorial Award:**

- Review your candidate's qualifications and weigh carefully the responsibility you are assuming, not only to the Society, but to the candidate as well.
- Prepare the proposer's statement and distribute the endorser statement forms to two members who will provide supporting endorser statements. The proposer and the two endorsers must be PSA members in good standing. Describe in detail the efforts and activities of the candidate to acquire and retain PSA members.
- Use the proposer and endorser statement forms provided. The proposal shall be a maximum of four pages (two from the proposer and one each from the two endorsers). It may be typed or hand-printed with a type font no smaller than 10 point.
- Mail the complete package (signed proposer's and two endorsers' statements) to the Membership Vice President before the June 1st deadline. A list of the PSA members referred by the candidate will be prepared from the referral database and attached to the statements.

The Joseph P. Fallon, Jr., Memorial Award Committee will review the proposals and the Membership Vice President will notify the proposer of the results by June 30th.

The Joseph P. Fallon, Jr. Memorial Award is presented during the Opening Meeting of the PSA Annual Conference.
